

- That the lessee shall not sublet or relet the portion of the premises to any one whoshever without consent/permission of the owner/lessor
- That the lessee during the period of tenancy shall not make any loss and dan ages to the leased area and if occurred the same shall be repaired /reimburse at his own cost and expenses and shall keep the premises in neat, clean and good in conditions. 
